## CERTIFICATE OF LIABILITY INSURANCE FORM

### IMPORTANT!

**DEADLINE: JULY 25, 2007**

As an exhibitor in a show, you need adequate **Liability Insurance with a minimum \$2,000,000 limit** to protect the exhibitors, the attending public, the show organizer and yourself.

Previous studies indicated that most exhibitors participated in shows without insurance or with inadequate coverage. For reasons of safety, security and responsibility to everyone, MIAC 2007 & PAL Showcase exhibitors **MUST** provide proof of adequate insurance 30 days prior to the opening show day. We realize this is another added responsibility to your busy schedule, however, it is one we cannot take for granted!

Once you confirm coverage with your insurance representative, request a Certificate of Insurance to be issued listing the MIAC, the Toronto International Centre and GES Canada Exposition Services as additional insured.

**There are two (2) ways to arrange the required insurance.**

#### OPTION 1:

Show Management has appointed Nacora Insurance Brokers Ltd. as the Official Insurance Contractor. We have been able to negotiate an extremely low premium package, which satisfies all our minimum insurance requirements (Please see inside front cover pocket for application form).

#### OPTION 2:

Alternatively, contact your insurance representative to confirm that your coverage meets the following minimum requirements.

**\$50,000 Property of Every Description. All Risk, Broad Form, Subject to \$1,000.00 Deductible, excluding E.D.P. coverages 100% Co-insurance. Property in transit to the limit insured above. Subject to \$2,500 Deductible.**

**\$2,000,000 Commercial General Liability, Bodily Injury and Property Damage Liability, Subject to \$1,000 Bodily Injury and Property Damage Deductible Inclusive each Occurrence - Products and Completed Operations Liability, Blanket Contractual Liability, Employees as additional insured's, Contingent Employers Liability, Broad Form Property Damage, Personal Injury Liability, Cross Liability Clause, Severability of Interest Clause, Non-Owned Automobile.**

**\$100,000 Tenant's Legal Liability, MIAC/PAL Showcase named as an Additional Insured.**

**Show Management must receive your Certificate of Liability Insurance 30 days prior to the first day of move-in.** Show Management will be obliged to prohibit move-in unless appropriate documents are received.

Your understanding and compliance with this is greatly appreciated and we thank you in advance for ensuring the well being of everyone concerned.
