Barcode Scanning with Download

TERMS AND CONDITIONS

1. MicroSpec Registration Services, hereinafter called "The Company" agrees to provide electronic lead retrieval services to the customer for the agreed upon fee, listed on the reverse side.
2. The method of payment shall be in Canadian dollars and submitted with the order for service. Payment will only be accepted by means of credit card (MasterCard, Visa or American Express). All orders will only be charged for the amount of the sale or as stated in topic 3 in this article.
3. The Company will furnish its equipment to the customer in good working order and the customer agrees to return the equipment to The Company in the same condition. The customer agrees to the immediate payment, upon request by The Company for all damages or loss of The Company's equipment, except such as may result from normal operation thereof; the customer acknowledges and understands that the total replacement cost of System 1 is \$1,500. The customer authorizes the company to charge the credit card \$500.00 for failure to return the unit within one hour after the official hall closing and the above replacement cost for failure to return the unit to the MicroSpec office within 72 hours from midnight of the official hall closing. The customer authorizes the company to charge the credit card the above replacement cost for each damaged unit.
4. The Company will use all reasonable care in handling the System 1 unit; however, the Company shall not be responsible for any special, incidental or consequential damages arising from the loss of such information, for any reason, arising from or relating to The Company's equipment. The Company's liability for damage of any cause whatsoever will be limited to the total price for the goods and services provided by The Company as listed on the reverse side.
5. Customer agrees to return all equipment to The Company's service desk within one hour of the show closing and must obtain a written receipt for the equipment. **Equipment left in the exhibit area is the responsibility of the customer.**
6. It is agreed that the governing law pertaining to this contract will be the law of the Province of Ontario.
