## **CERTIFICATE OF LIABILITY INSURANCE FORM**

***IMPORTANT - Please take care of immediately!***

**DEADLINE: JULY 10, 2009**

As you may know, as an Exhibitor participating in a show, you must have adequate Liability Insurance with a **minimum \$2,000,000** limit to protect the Exhibitors, the attending public, the show organizer and yourself. **Our insurance policy does not extend coverage to any exhibits and requires you to submit a Certificate of Insurance upon receipt of the exhibitor's manual.**

The results from a nationwide survey, has clearly indicated **A CRITICAL FACT** - some of the Exhibitors surveyed were in shows without insurance or with inadequate coverages.

Once you confirm coverage with your insurance representative, request a Certificate of Insurance to be issued listing the MIAC, the Toronto International Centre and GES Canada Exposition Services as additional insured.

**There are two (2) ways to arrange the required insurance.**

### **OPTION #1: With Nacora Insurance Brokers Ltd.**

### **OPTION #2: Your own Insurance Company**

- Alternatively, you can have your insurance company prepare a certificate of Insurance which must have the following: **Music Industries Association of Canada (MIAC) listed as an additional Insured**

- *Event name **MIAC & PAL SHOW***
- Comprehensive General Liability of \$2,000,000
- Bodily Injury and Property Damage Liability
- Subject to \$1,000 (maximum) Bodily Injury & Property Damage-Inclusive each occurrence
- Products and Completed Operations Liability
- Contingent Employers Liability
- Broad form Property Damage
- Cross Liability clause
- Severability of Interest Clause

**Show Management must receive your Certificate of Liability Insurance 30 days prior to the first day of move-in.** Show Management will be obliged to prohibit move-in unless appropriate documents are received.

**\$2,000,000** Comprehensive General Liability – Bodily injury and Property Damage Liability, Subject to \$1,000 BI & PD Ded – Inclusive each occurrence –Products and Completed Operations Liability \$2,000,000 annual aggregate, Employees as additional insureds, Contingent Employers Liability, Broad Form Property Damage, , Cross Liability Clause, Severability of Interest Clause.

**\$100,000** Tenants Legal Liability – Broad Form
